From September 2014, **all children attending Reception, Year 1 and Year 2** are offered a free school meal as part of the Government's Universal Free School Meals for Infants programme.

We need every family to complete the attached application to confirm that you wish your child/ren to take the free school meal. Please return this form direct to the school. If you do not receive a benefit please complete Parts 1, 2 and 4 only.

If you also receive a benefit as listed in Part 3 of the form the school will also receive additional funding known as Pupil Premium funding, but you must apply for this. This could be up to £1300 which will go towards supporting your child within school.

The Governors at Hethersett Woodside have decided to offer an incentive to parents to apply for this additional funding. For every child that triggers this pupil premium funding the school will provide £30 of school wear vouchers annually. These vouchers can only be used to purchase school uniform from the Schoolwear Centre.
